SOUTH & CENTER CHAUTAUQUA LAKE SEWER DISTRICTS (S&CCLSD) COUNTY OF CHAUTAUQUA, NEW YORK

PROJECT ABSTRACT: SCADA/BACKUP POWER (SCADA=Supervisory Control And Data Acquisition)

The S&CCLSD is a Chautauqua County Government Enterprise Department whose service mission is to protect human health and the environment from pollution. The Sewer Districts were formed in 1969 to protect Chautauqua Lake and the associated watershed (Mississippi River/Gulf of Mexico). Existing Town and Village sewers constructed during the 1930s and 1940s were accepted by S&CCLSD. A \$50,000,000 sewer expansion and treatment works project occurred during the late 1970s and early 1980s.

THE PROJECT IS TO REPLACE AND UPGRADE THE ORIGINAL 25-30 YEAR OLD REMOTE EMERGENCY CONDITION ALARM AND MONITORING SYSTEM. ALSO, THE PROJECT INCLUDES INSTALLING A PERMANENT STANDBY POWER GENERATOR AT A PUMP STATION WHICH SERVES 3 MAJOR INDUSTRIES (CUMMINS ENGINE, FAIRBANKS FARM, & CHAUTAUQUA METAL FINISHING). **THE WORK CAN BE ADVERTISED FOR BIDS WITHIN 60 DAYS OF FUNDING COMMITMENT.**

THERE ARE 12 MAJOR PUMP STATIONS (11 WITH EXISTING STANDBY POWER NOW) PLUS SEVERAL OTHER PUMP STATIONS AND THE WASTEWATER TREATMENT PLANT SERVED BY THE EXISTING EMERGENCY ALARM SYSTEM. THE EMERGENCY ALARM AND MONITORING SYSTEM IS BEYOND THE DESIGN USEFUL LIFE OF 20-25 YEARS. THE PROJECT WILL ASSURE RELIABLE AND COST EFFECTIVE EMERGENCY MONITORING OF CONDITIONS, WHICH LEFT UNRESOLVED WILL RESULT IN SEWAGE BACKUP INTO HOMES & BUSINESSES AND CAUSE SPILLS OF RAW SEWAGE INTO THE ENVIRONMENT. THE PERMANENT GENERATOR AT THE INDUSTRIAL PUMP STATION WILL PREVENT SEWAGE BACKUPS AND SPILLS WHEN PUBLIC ELECTRIC UTILITY IS OUT OF SERVICE. THE PROJECT IS VERY LABOR INTENSIVE WITH ESTIMATED PAYROLL COSTS AS FOLLOWS:

THE SEWER DISTRICTS HAVE INCURRED RISING COSTS TO MAINTAIN THE AGING SCADA ALARM SYSTEM, APPROACHING \$100,000 SINCE 2001. THE SEWER DISTRICTS RECENTLY AWARDED A COMPUTERIZED MAINTENANCE MANAGEMENT SYSTEM (CMMS) CONTRACT THAT THE PROPOSED SCADA ALARM PROJECT WILL NICELY INTERFACE WITH. THE DISTRICTS PORTABLE TRAILER MOUNTED GENERATOR, THAT IS HAULED TO THE INDUSTRIAL PUMP STATION WHEN NEEDED IS 25 YEARS OLD AND MUST ALSO SERVE AS BACKUP FOR 20 OTHER MINOR PUMP STATIONS. A NEW PERMANENT BACKUP POWER GENERATOR AT THE INDUSTRIAL PUMP STATION IS PRUDENT.

THIS PROJECT DOES NOT REQUIRE ANY NYSDEC PERMITS NOR SEQRA CLEARANCES AND, AS THUS, IS "READY TO GO".
